Wilkes Barre, PA to Redners Grocery Store, Pittston, Plaza, 2000 N. Township Blvd., Pittston Township, Pittston, PA.

The notice of the hearing was duly publicized in the Citizens Voice on Friday, April 21, 2017 and Monday April 24, 2017. There was no one in attendance from the public.

Atty Hopp outlined for the supervisors the plans which have been submitted to the LCB showing the physical location of the restaurant which will be inside Redner's current location. Hours of operation, consumption and take out policies Mr. Hopp were discussed. Beer, Wine will be available for take out but alcohol will only be permitted to be consumed in the restaurant. Supervisor Schibacucchi questioned other locations and Atty Hopp pointed out that there are currently 8 license application on file with the LCB in various counties but not in operation as of yet. T. Best stated that this was a permitted use in the B2 district. Supervisor Rinaldi had several questions which were answered satisfactorily by Atty Hopp.

Mr. Bonita checked the Mercantile Tax Filing and advised that all mercantile tax forms for Redner's has been filed and paid.
