AN ORDINANCE AMENDING THE TOWNSHIP'S ZONING MAP

WHEREAS, the Township of Pittston is a duly authorized political subdivision; and

WHEREAS, the Township of Pittston has enacted a Zoning Ordinance 2013 (Ordinance)

WHEREAS, the Ordinance, Article IV ZONING MAP & ZONING DISTRICTS , including, inter alia, Section 401; and

WHEREAS, the C-I Zone presently provides for, inter alia, airport(s) as a conditional use; and

WHEREAS, the Township is desirous of providing for appropriate uses in the community; and

WHEREAS, the Zoning Map Amendment will promote, protect, and facilitate the public health, safety, morale and general welfare of the citizens of the Township of Pittston; and

WHEREAS, the Board of Supervisors of the Township of Pittston determined it to be in the best interest of the citizens of the Township of Pittston rezone a portion of land from C-1 (Conservation) District to I-1 (Industrial) as described below;

NOW THEREFORE, BE IT ENACTED AND ORDAINED, and it is hereby ENACTED AND ORDAINED AS FOLLOWS:

Section 1: The intention of the adoption of the zoning ordinance amendment to the current Pittston Township Zoning Ordinance 2013 dated 2-19-2013, may have been amended, which is incorporated herein by reference as if specifically set forth herein, is to hereby amendin so far as the Zoning Map to reflect a portion of land described below:

Map Amendment.

Change the zoning district classification of the following area as currently shown on the Pittston Township Zoning Map as noted below:

Rezone parcels of land from C-1 (Conservation) District to I-1 (Industrial), which is described as follows:

Portion of PARCEL NO. 3 (Luzerne County)

All that certain piece or parcel of land situate in the Township of Pittston, County of Luzerne and

Commonwealth of Pennsylvania, bounded and described as follows, to wit:

Beginning at a the intersection of the Lackawanna / Luzerne County line with the southwesterly

right of way line of the former Susquehanna Connecting R.R. Co., currently owned by the

Redevelopment Authority of County of Luzerne (Deed Book 1549 Page 238 Lackawanna County),

as shown on a plan titled 'Final Minor Subdivision Plan - Lands of GOEX INCORPORATED,

dated Revised 11/22/96 prepared by Nicholas A. Piccini, P.L.S. and recorded in Map Book 6A

page 2363 at Lackawanna County Recorder of Deed office.

Thence along said lands / former right-of-way line, the following ten (9) courses and

South 50°-59'-38" West, two hundred thirty-six and ninety-five hundredths (236.95) to a set 5/8"

diameter rebar in the northerly right of way line of lands N/F of the Pennsylvania Turnpike Commission:

Thence along said Pennsylvania Turnpike Commission lands, the following two (2) courses and distances:

8.) North 46°-15'-34" East, three hundred eighty-one and seventy-three hundredths (381.73) feet

to a set 5/8" diameter rebar set on the Lackawanna County / Luzerne County Line: Thence along said line and Parcel 2A, South 79°-08'-29" East, two thousand two hundred eighty five and one hundredths (2,285.01) feet to the point and place of beginning.

A copy of the full text of the Ordinance and this Amendment are on file in the Township Building with the Township Secretary, 421 Broad Street, Pittston, PA. The Ordinance and this Amendment are incorporated by reference into both the official ordinance book of the Township with the same force and effect as if duly during regular Township hours at the above address.

- **Section 2.** That the Zoning map is are amended to reflect a map change for a portion of land from C-1 (Conservation) District to I-1 (Industrial) referred to herein.
- **Section 3.** In all other respects, the Zoning Ordinance of Pittston Township, as amended, shall remain in full force and effect, and is incorporated herein by reference and made a part hereof.
- Section 4. The provisions of this ordinance are severable. If any part of this ordinance is declared to be unconstitutional, illegal or invalid, the validity of the remaining provisions shall be unaffected thereby. It is the intention of the Board of Supervisors of the Township of Pittston that this ordinance would have been adopted had such unconstitutional, illegal or invalid part not been included.

Section 5. This Ordinance shall become effective t the date of passage of this Ordinance or at the earliest time permitted by law.
