ARP Funds - Township received notification and deposit of \$176,242 which is the second installment of the American Rescue Plan enacted by the Commonwealth. Funds can be used for general operations in the Township.

Firemen's Relief - Township received notification and deposit of \$ 26708.31 which is the annual allocation from the Commonwealth of Pa. Funds must be turned over to the Firemen's Relief Association.

Audit of Firemen's Relief Association - an audit was conducted by the Auditor General on the Firemen's Relief Fund for the period January 1, 2019 to December 31, 2021. Auditor opinion concluded that for the period Jan. 1, 2019 to Dec. 31, 2021 the association, in all significant respects, complied with applicable laws as they relate to the receipt and expenditures of the association funds - except a finding of unauthorized expenditures in the amount of \$1014. Reimbursement was made by the Volunteer Fire Dept. to the Firemen's Relief Fund. Complete audit will be posted on the website.

Electronics Event - At the August 20, 2022 Electronic Event 32,000 lbs. of electronics were collected from residents. Twp. will be eligible for reimbursement from Luzerne County for costs incurred up to a maximum of \$10,000.

Annual Bag Distribution - Sept. 30 is the deadline for reimbursements to residents. To date, \$135,185 reimbursement for ambulance, sewer and Ptn Twp. Sewer Authority Maintenance fee checks have been mailed to residents.

SPCA Municipal Partnership Agreement - .Current agreement expires Dec. 31, 2022. A renewal agreement with a term 2023 to December 31, 2028 was received by the Township. Mr. Bonita read into the minutes a letter of commendation written about Officer Tamburello citing his professionalism in handling a situation at a local business. Letter will be placed in his file.

Ordinance Police Pension Ordinance

As a result of negotiations with the Police and FOP changes have been made to the existing Police Pension Ordinance amending the ordinance to provide for vesting for all current and future full time officers of Pittston Twp. Atty Finnerty has reviewed the changes as well as FRS Consultants and Duda Actuarial. Ordinance was advertised on Sept. 6, 2022 and September 15, 2022 and posted on the website.

OUESTIONS/CONCERNS

Comments were made from the audience questioning the logic behind the ordinance at this point and whether or not prior employees would be covered. Mr. Bonita responded that this was covered at several meetings held by the Supervisors and the individuals questioning the vesting. Based on professional opinions of our lawyer, our consultant and the Twp. actuary it was concluded that it is illegal to include prior employees under this ordinance. Unfortunately when the employee left there was no vesting provision in the ordinance.

Supervisor Rinaldi asked why we could not provide an exception. Mr. Bonita once again stated that he was advised that it is illegal to include prior employees under this ordinance. The ordinance was written to cover all CURRENT FULL TIME and FUTURE FULL TIME police officers. Mr. Bonita pointed out to all parties that there were three or four meetings to discuss the same issue. There is no portability (jobs in other municipalities do not qualify for years of service) and there is no provision for retroactivity. The prior Ordinance enacted in 2007 was specific - 25 years of service AND 55 YEARS OF AGE.
