

RESOLUTION 1-02 of 2009

A RESOLUTION OF PITTSTON TOWNSHIP, of LUZERNE COUNTY, PENNSYLVANIA, DECLARING ITS INTENT TO FOLLOW THE SCHEDULES AND PROCEDURES FOR DISPOSITION OF RECORDS AS SET FORTH IN THE MUNICIPAL RECORDS MANUAL APPROVED ON JULY 16, 1993.

WHEREAS, a Local Government Records Committee was created by Act 428 of 1968 and empowered thereby to make rules and regulations for records disposition; and,

WHEREAS, the Municipal Records Manual was approved by said Committee on July 16, 1993; and

WHEREAS, the Municipality of PITTSTON TOWNSHIP desires to dispose of records according to statutory requirements (APPENDIX A);

NOW, THEREFORE, BE IT RESOLVED by PITTSTON TOWNSHIP of LUZERNE County, Pennsylvania, that it intends to follow the schedules and procedures for disposition of records as set forth in the Municipal Records Manual approved on July 16, 1993.

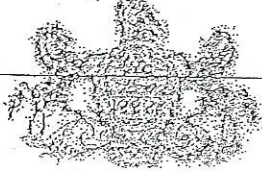
