The **2026 County/Municipal Real Estate Tax** bills have been mailed. If you do not receive your bill by March 9th, please call or email the tax collector

Payment by mail: mail payments to 25 Wall St. Pittston Twp, Pa 18640. **If you want a receipt, mail entire bill with your payment and a self addressed stamped envelope. A receipt is needed for Property tax rebates.**

A Valid/Official USPS Post Mark is accepted as timely paid, when postmarked by the due date. A prepaid postage meter date is not an official USPS post mark and is not accepted as being timely paid.

Make sure you have the post office manually stamp the envelope if mailing close to the due date as mail is not machine postmarked until it gets to the sort facility.

In person payments: **Bring entire bill for a stamped receipt.** The tax office is located at the Pittston Twp. Municipal Bldg., 421 Broad St. Pittston Twp. Office hours for in person payments are as follows:
February 23, 2026 to April 21, 2026; NO office hours March 14-22, 2026
Mondays 10 AM - Noon & 4 PM - 6 PM

Additional Days, Office Hours 4 pm -6 pm ONLY
Wed. April 8th; Tues. April 14th; Thurs. April 16th; Tues. April 21st & Tues. June 23rd

IMPORTANT 2026 COUNTY/MUNICIPAL RE TAX DATES

2/20/2026 to 4/21/2026- 2% Discount period

4/22/2026 to 6/23/2026- Payment at Face Value

6/24/2026 through 12/31/2026- payment at 10% penalty amount

ALL PAYMENTS MADE AFTER DECEMBER 15th MUST BE BY CASHIERS CHECK OR MONEY ORDER, BILL PAY IS NOT ACCEPTABLE AFTER 12/15 AS THESE ARE NOT BANK GUARANTEED FUNDS

Address Changes: It is very important to keep your mailing address updated. Updating your forwarding mailing address with the post office does not update your address at the Luzerne County Assessor's Office and the post office may not forward tax bills/notifications.
